## **Club Competition Rules 2025/26**

#### 1. Registrations & Nominations

- 1.1 A player is to be registered with the relevant Registrar at least 48 hours before he/she plays a league match with a club, provided that there has been no breach of Rule 2 Transfer of Players. This is done by informing the relevant Registrar in writing of the name of the player(s) and the age grade that they fall under (e.g. U.14, U.16, U.18 or Senior). Goalkeepers are to be indicated as "GK" on the list(s) submitted to the Registrars.
- 1.2 Each season, clubs shall forward to the relevant Registrar, to arrive no later than 3 days before the commencement of the relevant league competition, a list of the full names of 11 bona fide playing members of each team, called nominated players. Goalkeepers are to be indicated as "GK" on the list(s) submitted to the Registrars.
- (a) Clubs need not nominate players for their lowest registered team except where a club has a team in the U.18 and/or U.16 Girls League.
- (b) Where a club has more than one team in the U.16 Girls League 11 players for each team must be nominated, except for the lowest team. Players cannot play lower than their nominated team.
- (c) U.18 are those born in 2008 or later. U.16 are those born in 2010 or later.
- (d) Boys and Girls may not play Senior Hockey until they reach their 15th birthday.
- (e) Clubs must nominate 14 players to their 1<sup>st</sup> team if their 2<sup>nd</sup> XI compete in Division 1.
- 1.3 Players nominated on a given team shall be ineligible to play for a lower team.
  - (a) Where a player plays 3 games for a certain team, they must be nominated at no more than the club's next lowest team.
  - (b) Any player nominated on teams in Women's Divisions 1-6 cannot play in the U.18 and U.16 Girls League.
  - (c) Where an U.18 and U.16 player plays 3 games at a certain level, they must be nominated at no more than the next lowest level i.e. a club has 4 senior teams + 1 U.18 team + 1 U.16 team if the U.16 player plays 3 matches for that club's 3rd team they need to be nominated at no lower than the 4th team which would then make that player ineligible to continue playing with the U.16 or U.18 team.
  - (d) Aside from Rule 1.3(a), no player that plays in the Boys Senior League may be nominated to a Senior team.
  - (e) A team may use only <u>one</u> player nominated from a higher team as follows:
    - (i) If the nominated player normally plays in the *goalkeeping* position for their nominated team, they may play for a lower team in an *outfield* position.
    - (ii) If the nominated player normally plays in an *outfield* position for their nominated team, they may play for a lower team in the *goalkeeping* position provided that team has less than 11 players available to play at the start of the match.
  - (f) In respect of boys playing in the Senior Boys League & Senior Hockey:
    - (i) Players can play 3 matches at senior level during any 3 week period, and on their third match must take a 1 week break from senior hockey (they can still play in the Senior Boys League/Cup during this break).

- (ii) This rule does not apply to boys who go to non-playing hockey schools.
- 1.4 For clubs with two or more teams in a particular division, players can only be listed on team sheets for one of those teams in the same division on any given weekend (Friday to Sunday), except where the player is making up a full team for the bottom team in a club. In a further exception to this rule, Men's 2<sup>nd</sup> XIs who are in Division 1 and whose 1<sup>st</sup> team are also in Div.1 with them may select players to double up on any given weekend. However, the player(s) selected to double up cannot be one of the 14 nominated to their first team [as per Rule 1.3 (e)]. If a 2<sup>nd</sup> XI team chooses a player that is already playing with their 1<sup>st</sup> team on the same weekend, then the 2<sup>nd</sup> XI team will be capped at 13 players for their matchday squad.
- 1.5 The list of nominated players may be altered by 2 per team by giving 3 days' notice in writing to the relevant Registrar.

Any player removed from a club's nominations may play no lower than one team below the team they were originally nominated.

Where a team has altered its nominations, no further alterations shall be allowed for 4 weeks, other than dealt with in rules 1.6 & 1.7.

- 1.6 Where it is clear that a player will miss 3 or more consecutive matches through absence (except for International or Interprovincial duty), injury or suspension, clubs shall remove the player in question from the nominations immediately.
- 1.7 If a player does not play for their nominated team, or above, in any period covering 3 consecutive matches (except due to International or Interprovincial duty), the club shall be obliged to give a written explanation to the relevant Registrar and replace the player in question prior to the next match.
- 1.8 Where a player is removed from a club's nominations due to injury, absence or suspension (including across seasons); on their return they may play no lower than one team below the team where they were originally nominated.
- 1.9 Nominations for a season may not be altered after 1st March.
- 1.10 Cup nominations shall be those applying to the league 3 days prior to the cup match in question that the team plays in. Each member of a team competing in a Cup competition shall be a bona fide member of the club represented. Additionally, for cup matches which are played after 15th November in a season, they shall have played in at least two league matches in the current season for the team, or lower team in the club, in question that are due to play in a cup competition (includes U.18/U.16 Girls & U15 Senior Boys games).
- 1.11 Any team participating in EYHL1 will not be eligible to play in any Munster 'Plate' Competition.
- 1.12 Players can play for only one team in each cup competition.
- 1.13 Teams in breach of rules 1.1, 1.2 & 1.7 shall be dealt with by the Competitions Committee. The breach will be brought to the attention of the Competitions Committee by the relevant Registrar. The Competitions Committee shall award the points of all games where the club was in breach of the rules to the opposition and shall fine the club €100 for each breach of the rules 1.1, 1.2 & 1.7. Additionally, for league matches, the team will also be deducted 1 point. Additional defaults by the same team will carry an increasing penalty, which shall be an increment of one added point to the deduction of points for previous offence(s). For cup matches, the offending team will not be allowed

to participate further in that cup competition (includes Plate games).

- 1.14 Teams in breach of rule 1.3, 1.4, 1.8, 1.10 & 1.12 shall have the match awarded to the opposition. For league matches, the team will also be deducted 1 point. Additional defaults by the same team will carry an increasing penalty, which shall be an increment of one added point to the deduction of points for previous offence(s). For cup matches, the offending team will not be allowed to participate further in that cup competition (includes Plate games).
- 1.15 The Competitions Committee shall reserve the right to veto any Club's nominations and may impose conditions on certain nominations with a view to ensuring fair competition.

## 2. Transfer of Players

- 2.1 No player shall play for more than one club during the season in Branch competitions without the consent of the Competitions Committee.
- 2.2 When a player wishes to transfer from one HI affiliated club to another at any time of the season or between seasons, the club which the player wishes to join shall make an application for the transfer in writing to the relevant Registrar. This is done by fully completing and submitting the MBHI transfer form which can be found on the Munster Hockey website.
- 2.3 The club which the player is leaving shall not cause any unnecessary delay in the process of the transfer. Clubs (including underage Clubs) that cause any unnecessary delay shall be deemed to have brought the game into disrepute, and the matter shall be reported to the Disciplinary Committee who shall deal with the matter.
- 2.4 An application for a transfer shall not normally be necessary if the player has not played in Branch competition for one whole season or more.
- 2.5 If a club plays a player before he/she is properly transferred, the Competitions Committee will:
  - Remove any points gained by the team on which his/her name appears on the team sheet
  - Deduct an additional point from the infringing team.
  - Award the opposing team a win.
  - For a second and/or subsequent breaches of this Rule, the penalties as outlined above will apply together with an additional deduction of an increment of one added point to the deduction of points for previous offence(s) for each breach of the Rule. Rule 7.7 applies after a third breach of this Rule.
- 2.6 A player may only play for one club in any Branch Cup Competition.
- 2.7 Transfers shall not normally be approved after the 1st of January in any season. Exceptions may be allowed by the relevant Registrar for cases involving the inter-county change of residence of the player involved.

Note: Please refer to Hockey Ireland rules for the IRISH HOCKEY LEAGUE and Irish Cup competitions and to HI/EHF rules for International transfers where qualification for European competition is involved.

#### 3. League Rules

- 3.1 A team shall consist of a maximum of 18 players.
- 3.2 League points are awarded as follows:
  - Win = 3 points
  - Draw = 1 point
  - Defeat = 0 points
- 3.3 Competition hockey shall commence and end on the instruction of the Competitions Committee.
- (a) The League shall consist of a number of Divisions dependent on the number of participating teams in any season. Leagues shall consist of 8 teams, where possible.
- (b) Only the 1<sup>st</sup> Team of a club may play in Division 1 of the League.
- (c) In an exception to Rule 3.3(b) above, 2<sup>nd</sup> XI teams may compete in Women's Division 1 if their 1<sup>st</sup> XI team compete in EYHL1 and the 2<sup>nd</sup> XI earn their right to promotion from the criteria outlined below. \*This is an experimental rule to be reviewed at the conclusion of the 2026/27 season\*

A further exception has been granted to the Men's Leagues as a restructure is ongoing.

3.4 On completion of the League Competition, the team with the lowest number of points shall be relegated, except in the Lowest Division. However, if there is no team eligible for promotion no relegation will take place.

Promotion & Relegation will apply in the following way:

- (a) The teams that win their respective divisions are promoted and shall replace the team which is relegated from the next highest division.
- (b) 2<sup>nd</sup> placed team will play a play-off with the 2<sup>nd</sup> last placed team in the higher division.
- (c) For Women's Division 1-2 only If the winner of Division 2 is a club's first team, or a 2<sup>nd</sup> XI whose 1<sup>st</sup> team are/will compete in EYHL1, they are promoted to Division 1. If 2<sup>nd</sup> place in Division 2 is also a club's first (or eligible 2<sup>nd</sup> XI) team, they will play a play-off with 7<sup>th</sup> place in Division 1. If a 2<sup>nd</sup> XI team whose 1<sup>st</sup> team are/will not be competing in EYHL1 win Div.2 and a 1<sup>st</sup> XI (or eligible 2<sup>nd</sup> XI) team finish 2<sup>nd</sup>, that team will play a play-off with 8<sup>th</sup> place in Division 1.
- (d) Should a Women's Munster team get relegated from EYHL1 and their 2<sup>nd</sup> XI team are in Division 1, that 2<sup>nd</sup> XI team will be automatically demoted to Div.2 regardless of their league position. This scenario will affect promotion/relegation and play-offs between Div.1 and Div.2.
- (e) \*\*\* All of the above is based on the assumption that the net effect movement between Division 1 and IHL is zero (i.e. no team is promoted/relegated to/from IHL; or 1 team is promoted and 1 team is relegated to/from IHL). For a net effect movement of +/-1 or +/- 2 and for how promotion/relegation will be applied at the end of the 2025/26 season, including Men's new league structure, please see Appendix A to this set of Competition Rules.
- (f) In the event of 2 or more teams achieving the same number of points for a position that impacts winning the league, qualification for a HI competition, promotion or relegation there will be a play-off for the position in question. Play-offs for league position shall be organised by the Competitions Committee and shall be organised in line with Cup Rules below.

- (g) Teams will play the following season in the Division in which they are placed in from the previous season following promotion/relegation being applied. NO appeals to move will be considered.
- 3.5 In the event of a club withdrawing a team from competitive hockey, the team to be withdrawn should be from the lowest level unless otherwise approved by the Competitions' Committee. All matches played by the team in question shall be declared null & void.
- 3.6 Unless otherwise agreed with the Competitions Committee, any new team entered into competitive hockey by a club will be entered at the lowest level.
- 3.7 The Competitions Committee can alter the format of each Division as required, subject to approval of the Board of Directors.
- 3.8 U.18 and U.16 matches shall consist of 4 x 15 mins quarters.

## 4. Cup Rules

- 4.1 The drawing and organising of Cup Competitions shall be the responsibility of the Competitions Committee. All cup draws shall be open draws without seeding.
- 4.2 Matches shall be played on the ground of the team whose name is on top.
- 4.3 The dates and venues for all finals shall be the responsibility of the Competitions Committee. All finals should be played in neutral venues where possible and shall be played on synthetic pitches.
- 4.4 Umpires for cup finals shall be appointed by the MHUA.
- 4.5 The duration of all cup matches shall be 70 minutes (U.18 and U.16 matches 60 minutes). In the event of a draw the teams shall decide the result by a Shoot-out competition (no extra time) as per F.I.H. regulations.
- 4.6 A team shall consist of a maximum of 18 players.
- 4.7 Please refer to Appendix B to this set of Competition Rules for detail on cup formats with group stages.

## 5. Branch Trophies

- 5.1 All Branch trophies shall be perpetual challenge trophies and cannot be won outright.
- 5.2 All Branch trophies shall be signed for using the MBHI Trophy Receipt form.
- 5.3 All Branch trophies shall be returned to the Branch Administrator, clean & engraved, no later than 1<sup>st</sup> March the following year. Clubs will be billed if trophies are not clean and engraved.
- 5.4 Clubs failing to adhere to this rule shall be subject to a €50 fine.
- 5.5 Where a Club permanently mislays or damages a Trophy, the Club will reimburse the Branch with its replacement.

5.6 Where a Club permanently mislays or damages a Trophy, The Club will not be authorized to retain any trophy won the following season – the trophy instead will be held by the Branch following the presentation or awards ceremony.

#### 6. Fixtures

- 6.1 Fixture lists for the season shall be drawn up by the Branch Hon. Fixtures Secretaries. All communications in respect of fixtures will only be conducted between the Club's Fixtures Secretary and the relevant Branch Fixtures Secretary.
- 6.2 Matches shall be started no later than ten minutes after the time specified, unless previously notified to the opposition and the umpires.
- 6.3 A match cannot take place without two umpires officiating. In the absence of umpire(s), it is the responsibility of the captains to agree umpire(s), from their panel if necessary.
- 6.4 All division 1 and division 2 league and cup matches shall be played on synthetic pitches.
- 6.5 All division 1 (men's and women's) matches shall be scheduled to start between 12 noon and 3:30pm on a Saturday. For matches to be played outside these hours (including midweek matches), a written application must be made at least seven days prior to the date of the fixture to the appropriate Branch Fixtures Secretary and written approval from the appropriate Branch Fixtures Secretary must be obtained. Failure to comply shall be dealt with by the MBHI Competitions Committee.

Note: When Irish competitions are being played these matches will take precedence.

- 6.6 The home team shall give the time of the game to the visiting team (and MHUA for Division 1 and cup games) by 9pm on the Friday week (8/9 days) before the game, and if the team or umpires are travelling more than 50Km, the home team shall ask for their planned time of departure. Repeated failure to inform the opposition of match times before the cut-off time may lead to fines and/or reversing of fixtures.
- 6.7 No fixture may start at a time that requires a travelling team to depart before 9.00am except with the agreement of both clubs. Where a team is travelling more than 50km, no game may start after 4pm except with the agreement of both clubs.
- 6.8 For teams not covered under competition rules 6.5 and 6.7, no game may start before 10:30am or after 6pm except with the agreement of both clubs.

## 7. Postponements, Rearrangements & Forfeited matches

For the avoidance of doubt, the term "Postponement" in this rule encompasses the rescheduling of a fixture either to be brought forward or pushed back in the calendar.

7.1 Teams involved in Irish Competition (Irish Senior Cup, Irish Hockey Trophy, Irish Hockey Challenge, Irish Junior Cup, Chilean Cup, Mauritius Cup) on a particular weekend shall have their Munster fixture on that weekend postponed. In this case the relevant Branch Fixtures Secretary will re-fix the game.

Where a team have 3 or more players missing for a fixture due to International duty (matches and

camp only; NOT training sessions) they may request a postponement. The Branch Fixtures Secretary will fix the new date for this fixture.

- 7.2 All applications for postponements must be made in writing using the official postponement form which shall be sent to the relevant Branch Fixtures Secretary.
  - (a) All applications for a postponement must be made to the relevant Branch Fixtures Secretary at least 7 days before the scheduled date of the fixture in question. Applications for postponements are valid only if both clubs have specified an agreed date on which to play the fixture, subject to a deadline of 31st March. No application may be made unless this agreement is recorded in the application.
  - (b) The relevant Branch Fixtures Secretaries shall decide whether to grant the postponement or not. Branch Fixtures Secretaries will normally refuse to grant a postponement, even if both clubs agree, if in his or her opinion the reason for the application is inadequate.
  - (c) Once a decision is made on a postponement application, the Branch Fixtures Secretary shall notify the fixtures secretaries of both clubs involved in the application. A refusal to grant a postponement may be appealed to the Competitions Committee within 24hrs of the refusal. The Competitions Committee will make a final determination within 24hrs of receiving an appeal.
  - (d) If the club seeking the postponement does not secure the agreement of the opposition club, the game shall go ahead as scheduled. If the game does not go ahead, the Competitions Committee will apply the forfeiture rules -7.4, 7.5 & 7.6.
- 7.3 Branch Fixtures Secretaries shall not grant postponements if applications are not made 7 days prior to the date on which the fixture has been arranged, save in circumstances that are exceptional in the opinion of the relevant Branch Fixtures Secretary. In these cases, rearrangements will be set by the relevant Branch Fixtures Secretary.
- 7.4 With the exception of a club's lowest team, teams may only request 2 postponements (typically one pre-Xmas and one post Xmas) to play midweek on the grounds of non-substantiated player availability issues.
- 7.5 Where a team does not play its scheduled match on the given weekend, without prior official postponement, they shall be deemed to have forfeited the match.
- 7.6 The sanctions against a team forfeiting a match are as follows:
  - The opposition is awarded a win in the match;
  - For league matches, they shall be deducted one point for the first offence in the season. Additional offences by the same team will carry an increasing penalty, which shall be an increment of one added point to the deduction of points for previous offence(s).
  - Receive a fine of €100
  - In a cup match, the team will be unable to participate in any further part of the cup competition, e.g. a plate or runners-up cup & are fined €100. They will also be excluded in playing in cup competitions the following season.
  - For the next game where the forfeiting team is scheduled to play at home against the team they forfeited to, the fixture will be reversed, and the forfeiting team will have to travel (this may carry to the next season if there is no home game remaining in the current season).
- 7.7 Clubs (including underage teams) that forfeit more than three matches in a season shall be deemed to have brought the game into disrepute, and the matter reported to the Board of Directors

who may refer the matter to the Disciplinary Committee to deal with if necessary.

## 8. Pitch Unplayable

- 8.1 Where a team and/or umpire(s) is to travel more than 50km:
  - (a) If there is any doubt about the condition of a pitch due to weather, the home club shall ring the travelling team / umpire(s) before they are due to start the journey and either cancel or confirm the fixture.
  - (b) In the event that the away team has left and the weather changes to the point where the match cannot be played, the home team are obliged to contact the travelling team up to 1 hour before the planned fixture. This will only be valid in the case of unforeseen circumstances, and at all other times, 8.1(a) should be followed accordingly.
- 8.2 In the event that Rule 8.1 (a) or (b) has been used inappropriately the offending club shall be deemed to have brought the game into disrepute, and the matter will be reported to the Board of Directors who may refer the matter to the Disciplinary Committee to deal with if necessary.
- 8.3 If the procedure in 8.1 above is not adhered to and the travelling team arrives, and the match is not played, the fixture will be reversed, and the home team shall be fined €100. If umpires arrive and the match is not played their expenses shall be paid by the home team.
- 8.4 If the procedure in 8.1 above is adhered to and the match is subsequently cancelled by the umpires, the match will be re-fixed at the original venue. The relevant Branch Fixtures Secretary will re-fix the match.
- 8.5 If a match is called off by anyone other than the umpires, and in the umpires' opinion called off needlessly, the Competitions Committee will reverse the fixture.
- 8.6 Clubs must provide the names and contact details of two members who may be contacted by travelling teams.
- 8.7 Where a team refuses to play a game after the umpires agree the game can go ahead, that team shall be deemed to have forfeit the game and the forfeiture rules 7.4, 7.5 and 7.6 shall apply.

#### 8.8 Adverse weather warnings

- (a) In the advent of an adverse red weather warning the Competitions Committee will unilaterally cancel all scheduled fixtures. The relevant Branch Fixtures Secretaries shall re-fix any games cancelled in such an eventuality.
- (b) In the advent of an adverse orange weather warning clubs may seek a postponement of their scheduled fixture if the orange weather warning is scheduled during the time of their match and/or the time they are due to travel to/from the match. Agreement must be sought from the relevant Branch Fixtures Secretary before the game is officially called off. The relevant Branch Fixtures Secretaries shall re-fix any games cancelled in such an eventuality.

#### 9. Unfinished Matches

9.1 In the case of unfinished matches, the Competitions Committee shall, at its discretion, and having regard to the circumstances in which the match remained unfinished:

- Re-fix the match
- Reckon the result of the match as per the score at the time the match was stopped.
- Reckon the match as a draw.
- Reckon the match as forfeit by either or both teams.

#### 10. Result of Matches

- 10.1 Match cards shall be kept of every Branch Fixture which shall include the full names of the players on the panel, the name of the competition, the venue, date & time of the fixture. The number on every player's shirt shall match the number opposite that player's name on the match card. The player who played in goal in the match must be indicated with "(GK)" next to their name on the match card. The match card shall be completed by both teams and handed to the umpires prior to the start of the match by the Captain of the home team.
- 10.2 At the end of the match the umpires shall enter the score, name of scorer(s), mark any disciplinary card(s) used, sign, and return the card to the Captain of the home team.
- 10.3 Both teams must send a photo of the match card to their relevant Registrar and-the Umpires Registrar. For matches played Friday, Saturday or Sunday of a particular weekend to be received no later than 8pm on the Sunday of the weekend. Matches played at any other times the card must be received within 24 hours. If the card does not arrive in time, the relevant club shall be fined €20 for the first offence by a team & €40 for each subsequent offence. The original of the card is to be retained by the Home team in case it is needed at a later date.
- 10.4 The home club shall communicate the result of a match (or news of its postponement) to Sports Manager and to the relevant Branch Fixtures Secretary as soon as possible. Where news of a match result or postponement is not communicated to Sports Manager and to the Branch Fixtures Secretary by 8:00pm on a Sunday (for weekend results), the relevant club may be fined €50.
- 10.5 The match card should be an accurate record of the match played. Any deliberate falsification of entries on match cards shall be dealt with by the Competitions Committee who shall reckon the match as forfeited by the offending team and may report the issue for further sanction to the MBHI Management.
- 10.6 Notwithstanding 10.2 and 10.5 above, a score greater than ten goals, or a difference greater than ten goals, shall be reduced accordingly and the reduced score shall be entered on the match card. The score submitted to Sports Manager shall be that entered on the match card.

#### 11. Clothing & Equipment

- 11.1 Every affiliated club must have two sets of distinguishing colours that are registered with the Munster Branch.
- 11.2 Any change of colours by a club must have prior consent of the Munster Hockey Board of Directors.
- 11.3 Full Club uniform must be worn by all teams, including goalkeeping smocks for goalkeepers. Where colours are similar, the visiting team must change tops & socks. Any visible clothing including bicycle shorts, skins or bodywarmers must be of a similar colour to the player's team strip.

- 11.4 Players in all divisions of the League, and in all cup competitions, shall wear numbered shirts with no numbers duplicated. Failure to comply with this rule will result in a fine of €100 to the relevant club.
- 11.5 Captains must wear a distinctive armband or some other distinguishing item that clearly identifies them.
- 11.6 It is mandatory that all defenders defending a penalty corner must wear a face mask. If a team do not have enough face masks, they will have to defend the penalty corner with less players.

#### 12. Discipline

Please refer to Munster Hockey's Disciplinary Procedures and Regulations for rules pertaining to discipline. This document can be found on the Munster Hockey website. Should an individual receive a ban, these procedures and regulations are to be followed.

Please refer to Appendix C and D to this set of Competitions Rules for rules around Appeals.

## 13. Umpires

(i)

- a) All games under the remit of the Competitions Committee must be umpired by persons who have completed the Fundamentals of Umpiring Module 1. This is recognised by Hockey Ireland as the National basic umpiring qualification. All persons must be registered with Munster Hockey and be members of Hockey Ireland.
- b) All persons who have completed the Fundamentals of Umpiring Module 1, must apply to Munster Hockey for an umpire ID number. To receive this ID number all persons requiring an ID number must present evidence of passing the online rules test and completion of the Fundamentals of Umpiring Module 1 course, before being given an ID number.
- c) All umpires, who are members of the Munster Hockey Umpires Association or have completed the National Umpire Award Course in the past, and require an ID number, must submit proof of having completed the NUAC or proof of membership of the MHUA, before being given an ID number.
- (ii)
- a) All match cards for the above competitions must include the following in relation to the umpires for the game: match umpires' ID number, printed name and signature of match umpires.
- b) Where it is found that a team has not complied with the above requirements, they will forfeit any points gained from the match umpired by an unqualified umpire.

If both teams are found to be in breach of this rule the match will be declared null and void. It will NOT be refixed. To avoid any of the above sanctions both umpires who have umpired the game MUST satisfy (i) above.

Teams to be found in constant breach of this rule may have further sanctions imposed on them, including, but not limited to, those sanctions as laid out in Rule 7.5.

c) If the game is a cup match the offending team(s) will be excluded from the draw for the next round in the event of (i) and (ii)(a) not being complied with.

#### 14. Rules Test

- (a) All players competing in matches under the remit of the Competitions Committee MUST have passed the online rules test run by Hockey Ireland, in conjunction with the Irish Hockey Umpires Association. The club secretary must send to the relevant Registrar and Secretary of the Munster Hockey Umpires Association a list of players the club secretary is certifying as having completed the online rules course.
- (b) Where it is found that a team has not complied with this requirement, the game will be forfeited to the opposition, provided the opposition team has complied with section (a). A 1 point deduction will be applied, initially, to any team participating in a league game not in compliance with section (a). For a cup competition the offending team will be excluded from the draw for the next round. If both teams are found to be in breach of this rule, Rule 13(ii) (b)/(c) above will apply in addition to the deduction of points for league games as outlined above and (c) below.
- (c) Additional offences by the same team will carry an increasing penalty, which shall be an increment of one added point to the deduction of points for previous offences.

#### 15. Fines

A club with outstanding unpaid fines will be ineligible to take part in any Munster Branch competition, in the following season, until such fines have been paid in full.

## Appendix A - Promotion/Relegation criteria

#### Men

No promotion/relegation.

Men's leagues will be re-set at the beginning of next season.

Leagues will be determined on the previous season's rankings.

## Women

A. For zero net effect movement between Division 1 and IHL (i.e. no team is promoted/relegated to/from IHL; or 1 team is promoted and 1 team is relegated to/from IHL):

#### Division 1:

- 8<sup>th</sup> place relegated (only if eligible team win Div.2)
- 7<sup>th</sup> place vs. 2<sup>nd</sup> Div.2 in a play-off (only if eligible teams finish in 1<sup>st</sup> & 2<sup>nd</sup> place in Div.2)
  OR
- 8<sup>th</sup> place vs 2<sup>nd</sup> Div.2 in a play-off (only if non-eligible team win Div.2 but eligible team finish in 2<sup>nd</sup> place)

## Division 2:

- 1<sup>st</sup> place promoted (eligible team only)
- 2<sup>nd</sup> place vs . 7<sup>th</sup> Div.1 in a play-off (only if eligible teams finish in 1<sup>st</sup> & 2<sup>nd</sup> place)

- Relegation will be as per Rule 3.4.

- 7. Play-offs, ½ finals and final will be played in line with cup rules above.
- 8. All other Competition Rules above are applicable to the group stages of the Charity Cup (please note Rule 1.10).

#### Women's Examiner Cup

- 1. Eligible teams: a) Div.1 teams not competing in EYHL2
  - b) Div.2 1st XI teams
- 2. Teams will be split into 2 groups of 5 or 6 teams each.
- 3. Each team will play all other teams in their group once. Only 1<sup>st</sup> XI Div.2 teams will be guaranteed three home games.
- 4. Points will be awarded as per League Rule 3.2 above.
- 5. Top two teams in each group will qualify for the ½ finals. 1<sup>st</sup> in Group A will play at home to 2<sup>nd</sup> in Group B, and 1<sup>st</sup> in Group B will play at home to 2<sup>nd</sup> in Group A.
- 6. In the event that 2 or more teams are tied in a qualifying position for the ½ finals, the following criteria will be used to determine a qualifier:

## Women's Division 3/4 Combined Cup

- 1. Teams will be split into 4 groups of 4 teams each.
- 3. Each team will play all other teams in their group once. Only Div.4 teams will be guaranteed two home games.
- 4. Points will be awarded as per League Rule 3.2 above.
- 5. 1<sup>st</sup> place in each group will qualify for the ½ finals. Draw for ½ finals will be an open draw with first name drawn in each pairing having home advantage.
- 6. In the event that 2 or more teams are tied in a qualifying position for the ½ finals, the following criteria will be used to determine a qualifier:
- i) if a team already gave a walkover in the group stage, they will be automatically removed from the equation.
- ii) result of the match between the teams concerned.
- iii) a play-off will be organised to determine a qualifier.
- 7. Play-offs, ½ finals and final will be played in line with cup rules above.
- 8. All other Competition Rules above are applicable to the group stages of the Div.3/4 Combined Cup (please note Rule 1.10).

## Women's Division 5/6 Combined Cup

- 1. Teams will be split into 4 groups of 4 teams each.
- 3. Each team will play all other teams in their group once. Only Div.6 teams will be guaranteed two home games.
- 4. Points will be awarded as per League Rule 3.2 above.
- 5. 1<sup>st</sup> place in each group will qualify for the ½ finals. Draw for ½ finals will be an open draw with first name drawn in each pairing having home advantage.
- 6. In the event that 2 or more teams are tied in a qualifying position for the  $\frac{1}{2}$  finals, the following criteria will be used to determine a qualifier:
- i) if a team already gave a walkover in the group stage, they will be automatically removed from the equation.
- ii) result of the match between the teams concerned.
- iii) a play-off will be organised to determine a qualifier.
- 7. Play-offs, ½ finals and final will be played in line with cup rules above.
- 8. All other Competition Rules above are applicable to the group stages of the Div.5/6 Combined Cup (please note Rule 1.10).

#### **Appendix C - Appeals**

In the event of an appeal in a matter, other than a disciplinary matter, any affiliate, club, school, Association, official, player, coach, umpire or a member of any affiliated club, school, or Association wishing to appeal shall do so in writing to the Honorary Secretary of the Board of Directors. The Honorary Secretary, who must receive the appeal within fourteen (14) days of the date of the notice of the original decision, reducing to five (5) days in respect of decisions to do with fixtures, shall then convene an Appeal Commission.

The Appeal Commission shall consist of three (3) Directors of Munster Hockey's Board of Directors who may be accompanied by advisors where necessary but it shall not include any person who has had a prior involvement in the matter being appealed. In the event of there not being three (3) Directors eligible or available to form the Appeal Commission, the Chair of the Board shall have the power to select an appropriate person or persons to complete the Appeal Commission. The Appeal Commission shall meet within fourteen (14) days of the date of the receipt of the notice of the appeal.

The letter of appeal shall state the reason or reasons for the appeal and shall be supported by an appeal fee of one hundred Euros (€100). The appellant(s) shall have the right to be accompanied at the appeal hearing by a person or persons of their choice but the names and details of such person or persons must be included in the letter of appeal.

Both parties to the Appeal shall have the right to be accompanied at the appeal hearing by a person or persons of their choice but the names and details of such person or persons shall be notified in advance of the hearing to the Appeal Commission. Each party to the Appeal shall not exceed three (3) in number and shall have a nominated spokesperson.

The Procedure for the Appeal Hearing shall be as follows:

- An Appeal Hearing must be held once the procedures outlined above have been complied with.
- The Appeal Commission give both parties four (4) days' notice of the Appeal Hearing and in addition will notify both parties of the names of all those who will be attending.
- The Appeal Commission shall hear in the presence of both parties, unless otherwise agreed by all parties, the case presented by each party in the following sequence:
- 1. The appellant
- 2. The original decision maker (s)
- Both parties will have the right to respond to each other's' case
- The Appeal Commission will then discuss the Appeal in the absence of both parties
- The Appeal Commission may, if they so wish, recall each or both parties individually or jointly for further clarification
- The relevant parties shall be notified of the decision in writing by the Honorary Secretary within seven (7) days of the hearing.

In the event of the appeal being unsuccessful the appeal fee shall be forfeited to the funds of the Association unless the Appeal Commission decides otherwise. The decision of the Appeal Commission shall be final within the Constitution of the Munster Branch.

## **Appendix D – Disciplinary Appeals**

In the event of a disciplinary appeal, any affiliate, club, school, Association, official, player, coach, umpire or a member of any affiliated club, school, or Association wishing to appeal shall do so in writing to the Honorary Secretary of the Board of Directors. The Honorary Secretary who must receive the appeal within fourteen (14) days of the date of the notice of the original decision shall then convene an Appeal Commission.

The Appeal Commission shall consist of three (3) Directors of Munster Hockey's Board of Directors who may be accompanied by advisors where necessary but it shall not include any person who has had a prior involvement in the matter being appealed. In the event of there not being three (3) Directors eligible or available to form the Appeal Commission, the Chair of the Board shall have the power to select an appropriate person or persons to complete the Appeal Commission. The Appeal Commission shall meet within fourteen (14) days of the date of the receipt of the notice of the appeal.

All parties to the Appeal shall have the right to be accompanied at the appeal hearing by a person or persons of their choice but the names and details of such person or persons shall be notified in advance of the hearing to the Appeal Commission. Each party to the Appeal shall not exceed three (3) in number and shall have a nominated spokesperson.
